## **Membership Update**

John Clements reported that JPMGC has 175 paid members at this date. This includes 162 regular, 4 super senior, 7 junior, and 2 honorary members.

## **Tournament Report**

John Clements reported on the Spring Field Day on April 19<sup>th</sup> and the Stableford event on May 3<sup>rd</sup>. All tournament details are listed on the website.
